The Karuk Tribe requests proposals from qualified firms for the following scope of work: develop a set of schematic drawings, cost estimates, and site plan for the new construction of a Family Services Center located in Orleans, CA. The drawings should be for the new construction of a stick built, single story facility that meets all size and facility standards. The cost estimates should reflect the recommended type of construction, implementation schedule, and project management costs.

In order to establish accurate cost estimate for the site location it is required that the selected firm visit the site during the development of required documents. It is understood that these planning documents shall be delivered to the Karuk Tribe no later than 20 days from the date of selection.

Firms must include a statement of qualifications or resume with their submission. It is understood that this document may be submitted to funding sources in the future as a means to obtain funding for the renovation of this facility.
